

Affidavit of Financial Support

Instructions

Please read carefully before completing the Affidavit of Financial Support form.

All international students who require an M-1 student visa must submit an Affidavit of Financial Support form as part of the application process to International House of Prayer University (IHOPU). An affidavit is a written statement confirmed by oath or affirmation that serves as legal evidence. IHOPU requires documentation certifying the validity of the financial resources that are being guaranteed for a student's educational expenses. This evidence of support may consist of:

An official bank statement or original letterhead stationery, dated within six months of the start of the program, proving that sufficient funds are available to you

OR

A statement of support from a sponsor, along with evidence of the sponsor's financial resources in the form of an official bank statement, dated within six months of the start of the program.

Steps

1. Fill out your information in English and sign.
2. If you have a sponsor, fill in or have them fill in their information in English. Have them sign it.
3. Attach your and/or your sponsor's current official bank statement. Include a certified translation, if necessary.
4. Mail all documents to address below, or scan originals and email to internationaladmissions@ihopu.org

Guidelines

Sponsorship: All applicants must submit the form. The sponsor(s) must sign the form and all supporting documents. Upon receipt of the form, the sponsorship must be approved by IHOPU Admissions.

Timely submission: All Affidavit of Financial Resources forms must be dated within six months of the start of the program. The form and all supporting documents must be received by IHOPU no sooner than six months from the program start date.

Currency: The form and all supporting documents must clearly state US dollar amounts. Foreign currency amounts on bank documents will be converted to USD at current rates. These funds must be readily available to support the student's education. For example, real estate holdings or other non-liquid assets do not apply.

Dependents: Students planning to bring a spouse and/or children must provide evidence of additional financial support:

- A minimum of **\$6,000 for a spouse** for the school year (9 months) **or \$4,000 for six months**
- A minimum of **\$4,000 for each child** for the school year (9 months) **or \$2,700 for six months**
